BS Surgical First Assistant- New Degree

Rationale: The goals of this program are to: 1. Produce practitioners eligible for licensure to assist the surgeon in the operating suite but inclusive of inpatient and outpatient care, 2. Provide a pathway to a bachelor's degree in a health care field, 3. Provide an opportunity for a new graduate with a competitive rate of pay, 4. Improve health and increase access to Kentuckians for needed surgical services through workforce development.

Surgical First Assistants are governed by the medical licensure board. These practitioners play a complementary role to the lead surgeon in the operating room, as they directly assist the surgeon during an operative case. They manipulate tissue, aid in the visualization of the operative site, place catheters, suture, harvest veins, collect specimens, and administer local anesthesia. The program is highly specialized and will be sought after by those seeking a healthcare degree at the Baccalaureate level. This will be the only Surgical First Assistant program at the Baccalaureate level in the state of Kentucky. These individuals are also trained in robotics, microscopic techniques, and other surgical innovations. They can provide pre-op and post-op care. This program offers a pathway for pre-nursing students who are seeking alternative opportunities as well as other individuals who meet the prerequisites and are interested in health care. Students will experience robust rotations through a variety of surgical specialties which are overseen by the program director and the medical director. The program director will provide oversight over the implementation of the curriculum. Graduates will be eligible to sit for the national surgical first assistant exam. This type of provider will significantly help with workforce needs in the expansion of surgical services that serve all Kentuckians. This is not a nursing degree.

BSHS Clinical Leadership Management- Change Degree

Rationale: Purpose: The purpose of the Fall 2025 CLM Curriculum Update is to: 1) improve student access to CLM courses, 2) ensure that students are prepared for the courses they are taking, 3) remove redundancy, and 4) incorporate practice changes and updates. This program change includes the following specific changes:

- CLA 131 remove the requirement
- CHS 150 –remove the requirement
- CLM 120- increase from 2 credits to 3 credits and move from pre-major to major core
- CLM 324 allow the course to serve as a substitute for CLM 323
- CLM 453 remove the requirement
- CLM 470 add as a requirement
- Remove upper-level (300 plus) elective requirements, and increase elective requirements from 22 to 26
- Remove CLM 403 as a requirement

BASW Social Work, Change Degree

Rationale: The proposed changes include adding a newly developed course, SW 240: Career Readiness for Helping Professionals, to the required curriculum for the Bachelor of Arts in Social Work. Additionally, there is a proposal underway to include this course in the required coursework for the Bachelor of Arts and Bachelor of Science in Criminal Justice degree programs. The creation and implementation of this course will expand the 200-level course offerings for both programs. The proposed course will be a required course increasing the major course requirements. However, the proposal will also include a decrease in free elective hours therefore not increase the overall credit hour requirements for the program.

ECO 463- Change course (major)

Discussion: This is a proposed change to convert this course to a 400G-level course. The concern was raised that although a separate grading scale was listed for both undergraduate and graduate students, there was no differentiation in expectations (assignments or assignment expectations) between the graduate and undergraduate scale. The only different was that the graduate grading scale did not include a "D", but the cut-offs for the A, B and C were the same between the graduate and undergraduate students and there were no differences in expectations on assignments. It was the consensus of the committee that within all of the different colleges there is the expectations for 400G- and 500-level courses that there be some sort of increased expectation for graduate students in these courses (completion of additional assignments, added requirements to the assignment or a more rigorous assessment of the assignment). The reviewer will reach out to the proposer with this feedback and requested edits.

 - a) PRD proposals

Discussion: We are waiting to receive the 'Drop Course' proposals for the existing PRD 130, PRD 150 and PRD 151, since these course numbers will be used for other courses currently under review and we need to move these course changes through simultaneous. Due to the inter-related nature of the remaining course change proposals and the fact that they are all associated with the program change (proposal should be submitted ASAP), we are not going to approve any of the course changes until all PRD courses and the program proposal is ready for a vote, so that all items can move through together for the remainder of the review process. The exception will be any new PRD courses that are being created.

b) Proposal review for remainder of academic year

Discussion: With only 2 meetings left this academic year, the only new proposals that will be assigned to reviewers are those that are associated with proposals currently under review (ie. PRD proposals) or straightforward program change proposals. All other submitted proposals will not be assigned to reviewers until the "summer review" period. The priority for the April 22 meeting will be any program change proposals and associated courses (all PRD courses). If we can get all of these program changes approved at the April 22 meeting, we will do an electronic vote for the May 13 meeting.
