Primary Areas of focus for summer meetings:

1. Enhancing Faculty Senate operations for better impact and effectiveness. Themes may include defining what shared governance means and what it looks like in practice, exploring ways to build trust between faculty and administration, and reexamining the GR and AR that define the Faculty Senate to fully understand terms and processes outlined within them.
2. Connect with Staff Senate: Because Staff Senate meets 12-months of the year, we can attend meetings and connect with various committees to inform how we operate and identify opportunities for collaboration.
3. Hearing faculty concerns. In our role as senators, we are currently receiving questions and concerns from faculty regarding DEI, external grant funding, international students, immigration enforcement, and other timely issues of great importance to faculty on our campus. We can explore best ways to make ourselves a vessel for those concerns through the parameters of official Faculty Senate work.
4. Committee Work: SCC, SGC, and FAC will continue working on ongoing projects already underway and take on new initiatives as they arise.
5. Planning for a fall Faculty Senate retreat. Visioning for the future, exploring how we understand our role on campus, and goal setting for the coming year.

NOTE: Topics of discussion may expand and evolve naturally over the course of the summer. All senators are invited to contribute in ways they determine to be most beneficial to them and their faculty constituents.

Final Report

Because summer meetings will be unofficial, we plan to compile a report from our summer discussions to be submitted to the record as minutes in our first official Faculty Senate meeting of the fall semester.

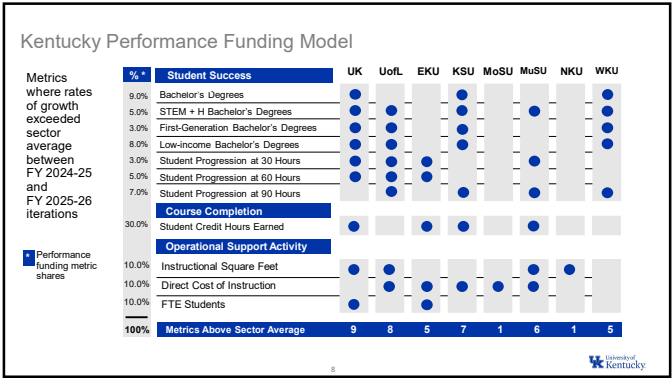
